5. The state Government will not bear any financial or administrative responsibility of the proposed school. The state Government will not be responsible. If the school/institution breached of any rules/norms or regulations laid down by above said board.
6. The institution shall have to obtain necessary permission to Government of India and other concerned authorities wherever it is necessary.
7. The school shall appoint only qualified and eligible staff as per the qualification laid down in R.T.E Act-2009/R.T. E rules.
